Bryan with Groundworks was directed to complete maintenance by 5/2/08. As of inspection on 6/5/08 maintenance was not complete. Groundworks is aware of overdue maintenance and was reminded to complete ASAP. This was not completed as of last inspection. 2) Erosion rills in outlot south of the club house and erosion in outlot northeast of closed sediment basin #9 needs to be repaired and area needs to be seeded and matted. Bryan with Groundworks was directed to complete maintenance by 5/2/08. As of inspection on 6/5/08 maintenance was not complete. Groundworks is aware of overdue maintenance and was reminded to complete ASAP. This was not completed as of last inspection. 3) Straw wattle at the bottom of the slope along Harrison Street is damaged and needs to be removed. Erosion rills also need to be repaired and slope needs to be seeded and matted. Bryan with Groundworks was directed to complete maintenance by 5/2/08. As of inspections on 5/21 and 5/23 maintenance was not completed. As of inspection on 5/30/08 maintenance was not complete. 4) Washout south of closed basin #1 needs cleaned out.
