Groundworks is aware of overdue maintenance and was reminded to complete ASAP. 2) Erosion rills in outlot south of the club house and erosion in outlot northeast of closed sediment basin #9 needs to be repaired and area needs to be seeded and matted. Bryan with Groundworks was directed to complete maintenance by 5/2/08. As of inspection on 6/5/08 maintenance was not complete. Groundworks is aware of overdue maintenance and was reminded to complete ASAP. 3) Straw wattle at the bottom of the slope along Harrison Street is damaged and needs to be removed. Erosion rills also need to be repaired and slope needs to be seeded and matted. Bryan with Groundworks was directed to complete maintenance by 5/2/08.
