The site was inactive during the last inspection for the Gallery 23 East project. Interior sanitary work is occurring by Thompson and major grading activities have ceased with the Gallery 23 East project by Pruss Excavation. Grading for water tie in along Rd 25 as of last inspection. Grading has ceased.

Lift Station and Sanitary Force Main projects are nearing completion. Work is occurring on the southeast intersection of County Road U and the project. County Road U Blvd and East 16th Street ditches will be stabilized in the coming weeks as of 8/30/2018. E&A will continue to monitor. Street ditches were seeded and matted prior to inspection on 9/19/18. During inspection on 3/5/19, the road side ditches on the E side of Hwy 275 for the sanitary project were covered in snow, therefore the status of the wattles could not be visually verified.

Water Improvements project has begun as of last inspection. Dirt piles from water main improvement project are being moved over to Gallery 23 East project in low areas. Dirt will be spread at a later date (2/7/19). Water project was active during last inspection.

Highway 30 intersection improvements project has not been transferred to E&A Consulting Group. Inc. for inspections or construction observation. E&A will continue to monitor and update when more permitting information is known.
