- 1) A few areas and the R.O.W. in the commercial area needs to be seeded. Developer Mike Huber was informed to seed areas by 9/3/09. Maintenance not completed as of last inspection, but due to the recent rains another seven days is given to complete maintenance until 9/10/09. Maintenance not completed as of last inspection. As of inspection on 12/7/09 seeding has not been completed and now due to frost in the ground seeding will have to take place in the spring of 2010.
- 2) A few areas of lot level silt fence is damaged in the home construction area and needs to be repaired. Mert w/ Hearthstone Production was informed that due to the ground being frozen he is to complete maintenance as soon as conditions allow.
- 3) There are a few piles of dirt in the R.O.W. in the home construction area and they need to be removed or install straw wattle around them. Mert w/ Hearthstone Production was informed to complete maintenance by 2/8/10.
- 4) There are a few full dumpsters in the home construction area and they need to be emptied or covered. Mert w/ Hearthstone Production was informed to complete maintenance by 2/8/10.
- 5) No maintenance is required in the BMP section.
