Existing Vegetation. The area West and East of the football field and track were seeded or sodded(11/3/15). Paving of the school addition has started (4/28/17). Parking lot islands and drainage easement along south side of football field stabilized (8/14/17). Area around the playground and basketball court on the east side of the school was sodded (8/30/17). River rock placed on parking lot islands around flared ends (12/4/17).

# Comments:

1.) Ralph Gladbach is now conducting site inspections and forwarding photos and site comments to E&A. No maintenance has been completed as of his last inspection. Seeding has been scheduled by the school superintendent for 5/21/18.

2.) Some additional minor grading and seeding has been completed as of 7/19/18, however heavy rains have caused additional erosion issues in all unstablized areas around the parking lot. Ralph Gladbeck is currently discussing issues with the school district and possible solutions.

2.) The area disturbed along the west end of the athletic field needs to be seeded and stabilized. BD Construction was informed to complete by 1/30/17. Not done as of last inspection. BD Construction was reminded on 3/21/17, 3/30/17, 4/16/17, 5/1/17, 5/24/17, 6/28/17, 8/20/17, 9/18/17, 10/25/17. The school district was reminded on 7/19/18.

3.) The sediment that has deposited in the drainage way along the south side of the site needs to be cleaned up. BD Construction was informed to complete by 1/30/17. Not done as of the last inspection. BD Construction was reminded on 3/21/17, 3/30/17, 4/16/17, 5/1/17, 5/24/17, 6/28/17, 8/20/17, 9/18/17, 10/25/17. The school district was reminded on 7/19/18.

4.) The area disturbed by utility work in the drainage way to the south of the site needs to be stabilized. BD Construction was informed to complete by 1/30/17. Not done as of the last inspection. BD Construction was reminded on 3/21/17, 3/30/17, 4/16/17, 5/1/17, 5/24/17, 6/28/17, 8/20/17, 9/18/17, 10/25/17. The school district was reminded on 7/19/18.

5.) Detention pond was completed and the area needs to be stabilized. Also a silt fence needs to be installed at the outlet pipe to prevent more runoff to ditch. BD Construction was informed to complete by 5/29/17. A piece of silt fence fabric was installed across the outlet pipe, but was not entrenched or secured. The pond was not stabilized as of the last inspection. BD Construction removed the silt fence from the outfall prior to the inspection on 6/14/17. BD Construction was informed to reinstall silt fence or a bale check at the outfall on 6/28/17 by 7/5/17. Not done as of the last inspection. BD Construction was reminded on 8/20/17, 9/18/17, 10/25/17. **The school district was reminded on 7/19/18**.
